1 – GENERAL TERMS AND CONDITIONS

All deliveries made, services rendered and offers submitted by Flughafen Erfurt GmbH are based exclusively on these general terms and conditions of business. These conditions therefore also aplly to any future business relationships even in the case that they are not agreed upon explicitly.

By placing an order the client tacitly accepts the following conditions, which rule out the need for any further special agreements to be made in individual cases. Flughafen Erfurt GmbH is not legally bound to adhere to the client's purchasing conditions even in the case it does not disagree to them explicitly.

Orders, agreements and sub agreements by Flughafen Erfurt GmbH or companies in cooperation with Flughafen Erfurt GmbH or acting on behalf of Flughafen Erfurt GmbH, become legally binding when they are confirmed in writing or are carried out by Flughafen Erfurt GmbH.

FEG reserves the right to reject an order after previously accepting it, if capacity regarding staff, vehicles and technical equipment is limited due to other binding obligations respecting the obligation of operation. The same is applicable in situations where execution of orders is impossible or cannot reasonably be carried out due to incidents beyond control, force majeure or industrial action.

Flughafen Erfurt GmbH is entitled to delegate any of the agreed services to subcontractors. FEG is responsible that the order is being executed as if by FEG itself.

Rates and prices provided in pricelists and offers are subject to change. All rates and prices listed in the official Regulation of Fees, or otherwise stated fees are net rates. I.e. German enterprises must pay the net rate plus the appropriate VAT amount, if not otherwise proven to be exempt by law. (§§4 Nr.2, 8UStG).

Orders confirmed or accepted by FEG are based on the credibility of the debitor (see Part 2.1).

Should it turn out that credibility is not guaranteed, FEG may immediately interrupt to continue completion of the order, but instead start negotiating with the debtor. Should negotiations not produce positive results, FEG is entitled to execute orders step by step only after having received payment or guarantees.

If not otherwise agreed upon individually or according to the contract no further specifications are indicated in the Regulation of Fees invoices

- will be issued on the day of completion of order
- will be payable immediately in full without reduction (e.g. expenses)
- will have to be settled in the country's legal currency



FEG accepts as means of payment by debit card, by credit card - Eurocard/Mastercard, VISA and American Express or by aeroPS via app.

Customers, who are paying on site, but did not pay before take-off, must pay an administration fee of € 10.00 in addition per invoice unless a specific day has been agreed upon previously when the invoice should become effective.

A debtor can be exempt from having to pay on site if either prepayment has been effected or a deposit has been made to the name of FEG or bank guarantee been given to the extend of the expected turnover within the next three months at a bank located in Germany.

FEG will reserve the right to change the fees or reduce the implementation of the order. The debtor will be informed accordingly.

In case payment has not been effected within the timeframe stipulated in the contract, FEG has the right to charge 2% interest per current month per year according to the amount set in § 288 (1) and (2) BGB, if not otherwise agreed upon, and also will request payment in cash or prepayment for future services rendered. In addition, FEG may charge a service fee of € 40,00 flat per payment request.

No landing fees for civil aviation flights operated by the federal government or a state of the Federal Republic of Germany. This exemption only applies to aircraft up to 5.700 kg maximum take-off weight and only if an offical aviation authority service flight certificate is presented for the flight.

Claims for obvious deficiencies regarding quality, quantity, tariffs or rates of any services rendered must be presented to FEG in writing within 14 days after issuing of invoice. The invoice is being confirmed and accepted as correct if no reclamation has been presented.

In case FEG accepts complaints, FEG may decide to offer replacement free of charge or will grant a reduction in price. All other claims the client may present, no matter on which legal ground, are excluded.


Within the law, the debtor has no right to demand compensation or the enforcement of the right to refuse performance.

The prohibition to demand compensation, respectively the prohibition of enforcing the right to refuse performance is not valid:

- If the debtor's claim has been recognised as lawfully confirmed, as undeniable or as up for further discussion.
- If the claim has expired, provided that this specific claim had not expired at the time, when the respective service could have initially been rejected or compensated.
- If claim and invoice have as ground the same airport user contract.

Regardless of aforementioned exceptions, compensation respectively enforcement of the right to refuse performance, originating from demands before the contract has been established or such demands not based on the grounds of the said airport user contract, based on which the invoice was produced in the first place, remain excluded.





At any given time, the then valid issue of the FBO – Flughafenbenutzerordnung – represents the Object of Agreement.

In case FEG grants reduction or leniency apart from their General Terms and Conditions, they will otherwise not be affected. Should single items of the General Terms and Conditions be ineffective, the remaining items will not lose validiy, but stay in effect. All deviations must be stipluated in writing.

Place performance Erfurt. of is Flughafen performance Judicial place of is if permissible Erfurt. Solely the law of the Federal Republic of Germany is binding – with the exclusion of CISG (United Nations Convention on Contracts for the International Sale of Goods).

The aforementioned General Terms and Conditions are legally binding in German language only.

All other versions in different languages are general translations.



2 – TAKE-OFF AND LANDING FEES, PASSENGER FEES, SECURITY FEES; PARKING FEES

2.1 GENERAL TERMS

debtor's clause

The following are debtors of take-off and landing, passenger, security and parking fees:

- The airline under whose airline code/flight number the respective flight has been carried out.
- The airlines as common debtor, under whose airline code/flight
- The person in whose name the aircraft is registered.
- The natural or legal person who is using the aircraft but is not necessarily the owner or person in whose name the aircraft is registered, such as a person renting or leasing the aircraft.

regulations for exceptions

In case take-off consequently follows an emergency landing due to technical problems with the aircraft or due to threatened or actual use of violence provided that the airport was not scheduled destination there will be no take-off or landing fee be effected, nor passenger or security fee. Diversions or landing for refuelling are not emergency landings.

date of payment

The take-off and landing, passenger, security and parking fees shall be payable in the currency Euro (€) or by credit card (Eurocard/Mastercard, VISA, American Express) or by the app aeroPS prior take-off. In certain cases payment can be effected at a later date if previously so agreed with the airport operator.

sales tax (VAT)

Take-off, landing, passenger, parking and security fees are fees according to §10, section 1 of the German Law on Sales Tax. Therefore, sales tax must be paid in addition, unless otherwise lawfully confirmed that the debtor is exempt from having to pay the VAT.



2.2 TAKE-OFF AND LANDING FEES

obligation to pay

Take-off and landing fees must be paid tot he airport operator each time an aircraft takes off.

Calculation of take-off and landing fees are based on the Maximum Take-Off Mass (MTOM) and must be paid also, when the aircraft touches ground only in order to accelerate immediately after to take-off again (touch-and-go).

calculation

Calculation for take-off and landing fees are based on the Maximum Take-Off-Mass (MTOM) indicated in the registration certificate of the aircraft, regardless of the operational criteria.

MTOM has to be proven by presenting the Certificate of Airworthiness (CofA). Until presented, the highest known MTOM for the individual aircraft type will serve as basis for calculation.

Any increase of MTOM must be made known and proof has to be presented. The airport operator may levy fees for the past, when the MTOM was already increased.

Any decrease of the MTOM must be made known and proof has to be presented. This will be considered with immediate effect, reimbursements for past invoices will not be be effected.

Rates for training and instruction flights will be reduced by 50%.

Trainingflights are considered flights, where student pilots are trained by an authorized aviation school and the purpose of those flights is to either extend his/her pilot's license or to get the civil pilot's license or which are required for aviation personnel according to examination regulations.

Instruction flights are considered flights, where pilots' flying and technical skills are being trained.

Instructors must possess the license/type writing for the airplane used for training and must be on board this plane while instructing.

2.3 PASSENGER FEE

obligation to pay

Passenger fees must be paid for each departing passenger on board a commercial or company charter flight. This does not apply to inspection flights of the official authorites in charge.

calculation

Calculation for passenger fees is based on the number of passengers on board an aircraft when departing. Children under the age of 2 years are not included in the number of passengers. Employees of the respective airline or another airline as well well persons on board who travel at a reduced price or free of charge are also considered passengers, for whom passenger fees must be levied. Excluded are members of the crew working on board.

Applicable Passenger Fee:

Next landing will be at a German airport

per passenger 2,94 €

Next landing will be at an airport outside of Germany

per passenger 4,40 €

¹ Company traffic are considered flights being undertaken to transport persons and goods in the interest of the respective enterprise and not on behalf of third parties against payment. Company traffic includes business flights of industrial and trading companies employing their own aircraft or aircraft let to them free of charge as well as flights of airlines for their own purpose.

2.4 SECURITY FEE

obligation to pay

In addition to take-off and landing fees as well as passenger fees, security fees must be paid to airport authorities for each take-off for commercial and company traffic.

The security fee is levied to refinance additional insurance costs, for covering war and terror risks as well as additional costs for performing official security requirements. Seucrity fees to not apply to inspection flights oft he respective official authorities in charge.

calculation

Calculation is based on the number of passengers on board an aircraft at the time of departing. Children under the age of 2 years are not included in the number of passengers.

Applicable Security Fee per passenger 0,49 €



2.5 PARKING FEE

obligation to pay

The airport operator levies a rental charge for parking an aircraft at the airport. A rental contract may be signed by the aircraft owner and the airport operator if the aircraft shall be parked for 30 days or more. For damaged aircraft which should be parked special agreements will be made.

calculation

Calculation is based on the MTOM, Maximum Take-Off Mass, and the duration of parking.

The fee to be paid for every 24 hours or part of it and per 1000kg Maximum Take-Off Mass or part thereof:

1,79€

Minimum parking fee:

4,09€

per each 24 hrs opened.

Parking fees will not be charged for a maximum of 4 hours between landing and take-off of an aircraft.

2.6 OFFICIAL AUTHORIZATION

Take-off and landing, passenger, security and parking fees are authorized by the Thuringian Government (Thüringer Ministerium für Bau, Landesentwicklung und Verkehr) and are in effect as of July 1st, 2008.



3 – GROUND HANDLING SERVICES

3.1 REGULATIONS AND DEFINITIONS

general rules / definitions

Ground handling services are carried out by Flughafen Erfurt GmbH (hereafter referred to as "airport") applying local procedures and all necessary systems and equipment according to international standards based on IATA AHM 810.

All services and tasks are carried out by trained staff. If so required a ground-handling contract is concluded between airlines and the airport.

On time performance of ground handling services can be guaranteed if the flights were announced in writing to the OCC (Operations Control Center) and confirmed with them at least 72 hours before the scheduled time of arrival. The flight number, type of aircraft, airport of origin and destination as well as scheduled time of arrival and departure have to be given.

If a scheduled flight arrives late and this delay causes delay in handling other aircraft which are on time the airport operator reserves the right to handle first the aircraft on time before handling the delayed flight. This also applies to diversions, which will be handled by the airport within its operational limits and to flights which have been announced and confirmed less than 72 hours before scheduled landing time.

The airline operator provides the airport with all necessary documents to enable proper ground handling. The airport ensures that all information given shall remain with the airport and will not be given to third parties unless required by law or governmental regulations.

The airport is entitled to delegate any of the handling servies to subcontractors, but remains responsible for proper service as if executed by itself.

In case of especially bulky or heavy cargo or if special cargo hast o be handled or to be loaded, offloaded or reloaded, the aiport must be informed in due time, if special equipment and special handling is necessary.

In case of an emergency (emergency landing or air traffic accident) the airport will immediately will take all necessary steps to assist crew and passengers and to prevent loaded goods inside the aircraft from being damaged or lost. The airport will be eligible for reimbursement of costs incurred.

basic groundhandling services:

The airport carries out ground handling services at the request of aircraft operators in accordance with IATA AHM 810 standards as far its equipment and



human resources allow. Ground handling services are described more closely in sections 3.2. and 3.3.

Provided that no other agreement has been made, this Directory of Services contains the basic ground handling services that are included in groundd handling. The airport will invoice addiontal services which go beyond the range of services included in the offical price list, separately.

In order to be able to provide proper ground handling the airport operator will use adequate systems and equipment and will, as far as possible, adjust those to confirm with international standards.

storage of airfreight:

The airport maintains a cargo storage, which may be used by airlines and freight forwarders. There is no claim that the storage can be used.

special ground handling services:

Special ground services are services not listed in Handling Agreements or not included in the basic services listed in the Directory of Ground Services (section 3.3.)

The airport will perform special ground handling services on request and subject to availability of staff and equipment. Special services can be agreed, when periodically performed, within the scope of a Contract on Ground Handling Agreements (SGHA).

Preparation time is included in calculation of charges which are based on time units. If not otherwise stated in the list of charges, the minimum charges will be based on the smallest time unit of 30 minutes.

Special services will be especially outlined in the invoices.

Recipient of services has to confirm on the order form that services have been delivered properly. If confirmation cannot be given the customer still has to bear the costs incurred so far even in the case that the customer and the recipient are not identical.

In case an airline requests a baggage check outside the usual baggage check requested by the authorities, it is regarded a special service and the airline has to bear the costs.

general aviation:

The airport maintains equipment, facilities and personnel for ground handling of general aviation flights.

other terms:

Fort he sake of better understanding, the following definitions and terminology shall aplly:

"passenger" includes the carrier's staff not working on board and freely travelling persons.

"cargo" includes the carrier's service freight.



"load" refers to baggage, also crew baggage), cargo (including service freight), mail (including company mail) and ballast.

basis for calculation of charges

Charges for ground handling services and General Aviation are package prices. There will not be a reduction for single elements out of the package, but the package price will be charged.

The airline is to pay a handling charge for ground handling services carried out by the airport. This charge can be based on the range of ground handling services or the number of ground handling service processes stipulated in a Ground Handling Agreement. If no such contract exists, ground handling services will be charged according to fees published in the Regulation of Fees, section 3.6. (ground handling) respectively section 3.8. (passenger handling and OPS services).

Services, which are requested, but are not contained in the Regulation of Fees will be charged according to the list of Special Services, section 3.9.

The following are debtors of handling fees:

- The airline under whose airline code/flight number the respective flight has been carried out
- The airline as common debtor under whose code/flight number the respective flight has been carried out (code-sharing)
- The aircraft operator
- The natural or legal person who who is making use of the aircraft and is not necessarily the owner, but renting the aircraft or leasing it.

liability

The airport is liable to the airline if ground handling services are not properly carried out and if it can be proven that any damage was caused by intent or gross negligence.

The airport is liable for loss of luggage, air cargo, air mail, live animals within legal regulations. The airport must be given notice in due time prior arrival of especially valuable goods and immediately if they are already on ground at the airport.

Compensation is limited to € 500,000 per damage.

The airport is not liable for damage to property.



3.2 DIRECTORY OF USE OF THE CENTRAL INFRASTRUCTURE OF GROUND SERVICE

basis for calulation

- Provision of aprons equipped with lighting systems including taxiways and areas located nearby parking positions in order to keep ground handling vehicles and equipment ready.
- Parking of the aircraft for ground handling for 4 hours. After 4 hours the airport may decide to move the aircraft to a different parking position for operational reasons.
- Use of taxi areas for taxiing between taxiways and aprons.

passenger boarding bridges

- Provision of passenger boarding bridges including boarding stations for handling near to the terminal building.
- Operating the passenger boarding bridge during handling process.

stationary ground power supply

- Provision of stationary ground power unit at passenger bridges.
- Connecting and disconnecting ground power unit with/from aircraft.
- Providing ground power is part of ground handling services.

baggage conveyor system

- Providing and operating of a baggage conveyor system for arrival and departure.
- Providing systems for baggage handling including adequate space and handover areas.
- Sorting and preparing baggage.
- Transportation of departure baggage to point of handing over.
- Transportation of arrival baggage from point of collecting to baggage claim or to delivery point for transfer.
- Handling of transfer luggage, bulky luggage and courier shipments.

facilities for aircraft marshalling

- Surveillance of operational safety on apron and apron control.
- Provision of Follow-Me vehicles.
- · Carrying out marshalling.

flight information system

 Provision and operation of systems to send out relevant information to all service providers and passengers at the airport.



- Provision of office space and for traffic management and passenger information.
- Organizing flight planning and apron control.
- Maintaining an information counter inside the main terminal.

fresh water supply system

- Maintaining adequate areas for fresh water supply systems with potable water quality according to legal regulations and filling station as well as a garage for frost free storage of water supply vehicles.
- Providing fresh water for aircraft is part of ground handling services.

toilet disposal system

- Provision of facilities to empty lavatory units.
- Provision of facilities for frost-free storage and filling of vehicles as well as keeping disinfectants in stock.
- Lavatory service is part of the ground handling service.

waste dispolas system

- Maintaining areas and technical facilities for collecting and processing waste in ways suitable for the differenct types of waste.
- Providing waste containers.
- Waste disposal is part of ground handling service.

3.3 DIRECTORY OF GROUND HAND-LING SERVICES

loading and offloading

- Provision, transportation and operation of passenger gangways.
- Provision, transportation and operation of loading and offloading equipment
- Provision and operation of vehicles of suitable capacity for transportation of passengers between aircraft and terminal.
- Additional trips on request of the airline (last-minute-passengers, crew transporation) are special services.
- Provision and operation of wheelchairs and vehicles for transportation of handicapped passengers between the check-in desk and the aircraft respectively the aircraft and public areas inside the terminal building. This service must be requested in advance.
- Opening and closing of cargo doors.
- Operation of loading equipment on board the aircraft.
- One-time offloading of load according to airline instruction.



- Provision and operation of suitable equipment for transporation of the load between the aircraft and point of handing-over or between the operator's airplanes according to his/her instructions.
- Handing over/receiving loads.
- One-time loading, stowing, securing the load properly prepared according to the airline's instruction provided that these comply with German law regarding health and safety standards, e.g. regarding accident prevention.
- Lashing material to be provided by the airline, otherwise it will be charged as special service. Sorting out baggage items after loaded and stowed inside the aircraft will be charged as special service.
- Use of suitable measures to protect pallets, containers, nets, belts securing hooks and other materials for scuring loads provided by the airline against loss or damage. Any kind of damage or loss must be reported to the airline.
- Provision of storage for ULDs (unit load device) and protection against weather influences.

aircraft handling

- Provision, positioning and removal of chocks.
- Provision, transportation and operation of stair for crew.
- Provision of mobile ground power units.
- Providing ground power to aircraft for 60 min. Ground power for more than 60 min will be charged as special services.
- Provision of air power units (APU) to boost the engine start. This will be charged as special service.
- Provision and operation of mobile air conditioning units (ACU). This will be charged as special service after 15 min.

3.7 SURCHARGES AND REDUCTION ON HANDLING FEES ACCORDING TO SECTION 3.6

separate handling

Surcharges of 25% of the handling charges apply in case ground time between on-block and off-block exceeds 4 hrs.

night handling

Surcharges apply for handling of flights between 08:00 pm (on-block) and 06:00 am (off-block) local time:

- 25% for handling between 08:00 pm and 00:00 am
- 25% for handling between 04:00 am and 06:00 am
- 35% for handling between 00:00 and 04:00 am

technical landing and diversion

Handling in case of technical landing or diversion without change of load will be charged at 50 % of the handling fees.

ferry flights

Reduction of 20 % of handling charges apply for scheduled positioning flights with only one handling segment required. The reduction does not apply in case of ad-hoc handling of ferry flights.

handling od cargo planes

Charges and fees for handling cargo planes are not being published. Charges will be calculated based on the volume to be expected. In case an agreement can not be met, a surcharge of 25 % of handling charges published will apply. In case of especially bulky or heavy cargo or freight which exceeds the usual weights or dimensions or which needs special attention and care (animals) the airport reserves the right to charge these services and additional staff according to charges published in the Directory Speical Services.
